Orange County is seeking to enter into an engineering services contract with a state-registered engineer to assist the County in pre-award and post-award engineering services of its proposed HMA project(s), if funded under one or more of the following programs:

- Hazard Mitigation Grant Program (HMGP) for 2024
- Flood Mitigation Assistance (FMA) 2024

The following outlines the request for qualifications.

- I. <u>Scope of Work</u> The successful respondent(s) is to provide engineering services including but not limited to the following areas:
  - a. Mitigation Projects-Construction (other than Property Acquisition/Structure Demolition, Structure Elevation, and Reconstruction)

<u>Pre-Award</u>\*--(services associated with developing and requesting Federal disaster assistance), including but not limited to:

- Application preparation assistance
- Preliminary engineering study, if applicable
- Preliminary environmental and historical assessment
- Preliminary surveys, if applicable

\*Pre-Award costs to be reimbursed by FEMA must have been incurred after the date of declaration (HMGP) or grant opening announcement (FMA). (BRIC) Pre-award costs directly related to developing the BRIC grant Application or subapplication that are incurred prior to the date of the grant award are allowed subject to FEMA approval at time of award. All programs - Pre-award management costs count towards the limit for subrecipient management costs. Pre-award costs must be identified as separate line items in the cost estimate of the application. - A statement substantiating the firm' resources of and the ability to carry out the scope of work requested in a timely manner.
- III. For this RFQ, qualifications will be evaluated and the most qualified respondent will be selected, subject to negotiation of fair and reasonable compensation.

#### V. <u>Submission Requirements</u>

- **System for Award Management**.
