PLEA

NO CONTEST: A plea of NO CONTEST indicates that you are not contesting the charge against you and that you will take care of the assessed fine set by the Court and must be paid as ordered.

GUILTY: A GUILTY plea states that you are guilty of the charge against you. The fine is the same as a plea of NO CONTEST and must be paid as ordered.

NOT GUILTY: A plea of NOT GUILTY states that you are not guilty of the charge filed against you. **A plea of NOT GUILTY requires that you appear for trial at a later date.** Failure to appear for trial may result in a warrant being issued for your arrest. If found guilty your fine will be assessed by the Judge or Jury and must be paid at that time. If found NOT GUILTY charges against you will be dismissed.

Admonition for Family Violence Assault (Class C)

If you enter a plea of No Contest or Guilty, you will be convicted of a misdemeanor offense involving violence where you are or were a spouse, intimate partner, parent or guardian of the victim or are or were involved in another, similar relationship with the victim, it may be unlawful for you to possess or purchase a firearm, including a handgun or long gun, or ammunition, pursuant to federal law under 18. U.S.C. Sec. 922(g)(9) or Sec. 46.04(b), Texas Penal Code. If you have any questions whether these laws make it illegal for you to possess or purchase a firearm you should consult an attorney.

Time Payment Fee - \$15.00 per Case

If the full balance of the plan is not paid in full before the 31st day after the date on which a judgment is entered, I understand that a Time Payment Fee of \$15.00 per case will be added to the last scheduled payment. Payments must be received by each of the scheduled payment dates. I understand that if I should miss any payments as described above, the remaining balance will become due and payable in full, and/or WARRANT(S) will be issued for my arrest. I understand that a Capias Pro Fine could be issued against me.

I hereby waive trial and enter my plea as shown above, to the listed offense. I hereby state that I am not indigent. I further agree to pay the fine and costs as shown on my payment schedule.
